With reports of Instagram hacking seemingly increasing, Carter-Ruck has represented a British artist to recover and protect his Instagram account after it was hacked.

Shortly prior to the hack, the client reached a follower count of over 27,000, making him eligible for a verified account. He applied to Instagram for verification. Shortly afterwards the hacking occurred. This seems to be a common theme in Instagram hacking cases: hackers are aware of the follower threshold for verification and often target accounts which have recently passed the threshold, in the knowledge of how important these verified accounts are for business owners. The Telegraph and Ian Austin (the former Labour MP and now member of the House of Lords) have provided a full apology to Laura Murray before Mr Justice Saini in the High Court in London, following Ms Murray's successful libel complaint over an article written by Ian Austin in December 2021 which alleged, entirely falsely, that Ms Murray was an anti-Jewish racist. This follows on from the publication of full apologies on the Telegraph website and Twitter. Ms Murray has also received £40,000 in damages, as well as her legal fees. [Read more.](#)

## Susan Hamblin wins her libel and data protection claim against The Sun

Ms Hamblin's complaint related to three articles and a video published in The Sun on 2 and 3 July 2020 and 14 June 2021, which reported on a US legal claim alleging abuse by Jeffrey Epstein. The joint Statement in Open Court read before Mr Justice Nicklin in the High Court on 5 May 2022 made it clear that Ms Hamblin had nothing to do with the events reported in the US legal claim and the allegations made against her were entirely untrue. The libel claim is brought in the High Court in London and substantial damages are being sought, together with an injunction prohibiting further publication of the libellous allegations. ## The Times apologises to Mike Ashley and pays substantial libel damages over "protected" phone records allegations

Mike Ashley, the CEO and majority shareholder of Frasers Group plc (formerly Sports Direct International plc), brought libel proceedings over a series of articles published by The Times in July 2020. The articles concerned claims made by the founder of the mobile telephone company Sport Mobile that his company had "protected" Mr Ashley's phone records in the context of 2017 High Court proceedings against Jeffrey Blue. The Times has apologised to Mr Ashley and has withdrawn its allegations. [Read more.](#)

## Ontario Court of Appeal upholds dismissal of defamation action against Al Jazeera

The Court of Appeal for Ontario has dismissed an Appeal brought by the Rebel News Network against a Decision of 16 February 2021 to dismiss its defamation claim against Al Jazeera.

Al Jazeera Media Network relied on the Canadian "anti-SLAPP" legislation to win a motion to dismiss a defamation claim brought by Rebel News, a right-wing news organisation, that sued over allegations broadcast by Al Jazeera on its "Listening Post" programme in September 2019. [Read more.](#)
